Ratified seats

- Six "ex-ME" ratified seats were available: those held by Samsung, SK Telecom, AT&T, Siemens, T-Mobile, and Vodafone.
- Three "ex-SE/EE" ratified seats were available: those held by Credit Suisse, Fujitsu, and HP (IBM's SE/EE seat was eliminated.)
- Nominations for "merged" ratified seats:
 - Cinterion, Credit Suisse, Fujitsu, and HP.
 - AT&T, Siemens, T-Mobile, and Vodafone were not renominated.
- Five seats were held in reserve for 2013.
 - Three of them will be eliminated then.



Elected seats

- Two elected seats were contested in 2012: the seat held by the London Java Community and the seat vacated by CableLabs.
- Candidates: Cisco, CloudBees, Giuseppe Dell'Abate, Liferay, London Java Community, Morocco JUG, North Sixty-One, Software AG, Zero Turnaround.



The election

- Many candidates:
 - Nine for the two elected seats.
- Good voter turnout:
 - 24% turnout (compared to 23% in October 2011.)
- The winners:
 - Ratified seats: Cinterion, Credit Suisse, Fujitsu, and HP.
 - Elected seats: Cloudbees and the London Java Community.


