JSR 364 update

- The legal agreements are still working their way through Oracle's executive approval process.
 - The Associate Membership Agreement and Employer Contribution Agreement have "almost" completed the process.
 - Some (minor) changes will be required.
 - The Partner Membership Agreement is lagging somewhat.
- We cannot post the final materials until all approvals are completed.
- Final steps:
 - Publish Revised Process Document with minor updates from June EC Meeting & submit for Final Approval Ballot & Final Release once approvals received.


