EC meeting attendance



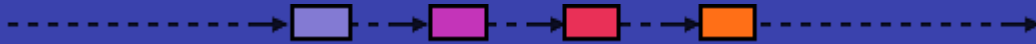
- EC members who miss two meetings in a row lose their voting privileges until they have attended two in a row.

Membership Report



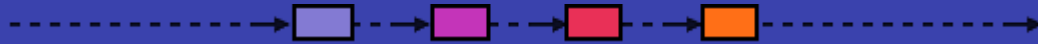
- 486 new membership agreements received since JCP 2.10 was introduced in May 2016.

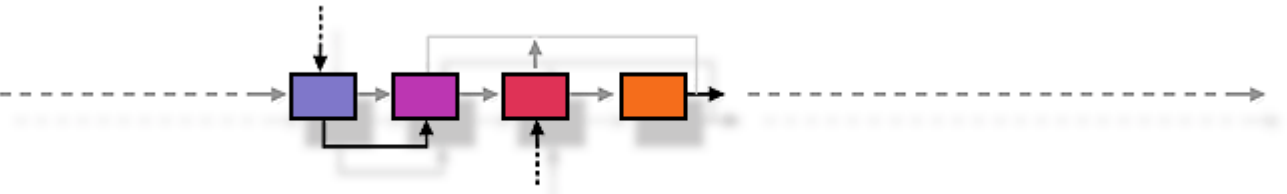
